Your data shall be kept on file for as long as it is required for the purpose of processing the legal relationship, after the end of which said data may be kept on file for a period of ten years to ensure their availability to the public administration, judges and courts of law in order to attend to and defend any possible liabilities arising from said processing. LORETO MUTUA recognises your entitlement to exercise the rights of access, rectification, deletion, limitation, opposition and portability of the data submitted, which may be exercised by sending a written request and attaching a document accrediting your identity to the postal address indicated above or by sending an email to the following address dpd@loretomutua.com. Likewise, please be informed that you have the right to withdraw your consent regarding the processing of your data by LORETO MUTUA, and that you have the right to file a complaint with the Spanish Data Protection Agency.

Please be informed that, to the extent that it is necessary for each of the purposes expressed in the previous sections, your data may be transferred to Loreto Inversiones SGIIC S.A, a company belonging to the LORETO MUTUA group (more information about Loreto Inversiones can be obtained at www.loretoinversiones.com). Said assignment, if it occurs, will be carried out with the same processing purposes, the same data categories, the same conservation period, and a similar exercise of rights.
