You may also withdraw the consent given for processing the data and make a complaint to the Spanish Data Protection Agency.

Grupo Loreto Mutua will perform its obligations to keep the personal data confidential and guarantee the adoption of the necessary security measures required by law that guarantee the security of the personal data and safeguard against its alteration, loss, unauthorised processing or access, taking into account the state of the technology, the nature of the data and the risks it is vulnerable to.
